



MALAYSIA'S ECONOMY TIPPED **TO POST HIGH GROWTH IN 2024 ONALL-ROUND** IMPROVEMENT **– DATUK DR NAZRI KHAN**

ccording to Inter-Pacific Asset Management (IPAM) chief economist and independent fund manager Datuk Dr Nazri Khan, Malaysia's economy in 2024 is likely to register high growth, driven by improved performance in all sectors. The local economy has performed significantly well across the board and he expects the momentum to continue next year.

During a press conference on IPAM's Market Outlook 2024, he said that he is optimistic that the economy is going to grow between 4.5% and 5%, at the higher end of 5%. It could be one of the best economic growth that Malaysia has achieved for the last five years. There are indicators that Malaysia's global trade has improved, particularly for its exports, and FDI which has increased markedly. Private investments have continued to be sustained. Across all sectors, the markets have also gone up, not only in the electrical and electronics (E&E) and technology sectors. Artificial intelligence (AI) will spill over into E&E and technology products. The construction sector has boomed, while property has also boomed slightly. On the plantation sector, he projects crude palm oil prices to increase to RM4,000 per tonne next year, from the current range of RM3,000 to RM3,500.

Touching on Bursa Malaysia, he is optimistic on the local equity market in 2024, underpinned by growing foreign participation. He sees signs of stocks accumulation that are patterns on the stock market that it may have bottomed. He added that he is optimistic on Bursa Malaysia as FDI has come in and foreign participation has gone up, which could be a sign that foreign investors are interested to invest on the exchange, maybe not so much on the IPOs, but on the large cap stocks.

The FBM KLCI is currently in the 1,460 to 1,470 range and he hopes that it will break the 1,500 mark within this month. He also hoped that it would reach a high of 1,900. He is of the opinion that at the moment the banking sector is the strongest sector in the stock market, followed by telecommunications. Moving forward, he feels that the technology sector will strengthen.

On another note, he said that IPAM will collaborate with a US company to introduce AI technology into its system in March next year, to help provide information on the stock market to investors. Investors will be able to make more informed investment decisions, with the help of this AI system in identifying stocks that are trading low and predicting which stocks have the potential to rise in the future.

He added that this AI technology can read chart patterns and fundamental patterns and that while it may not be accurate, the technology can simplify the process towards making the right investment decisions. He advised the public not to be deceived by

illegal investment syndicates or online scams that use his name, pictures and videos.

STRONGER ECONOMIC MOMENTUM FOR MALAYSIA IN 2024 – RAM RATINGS

RAM Ratings expects Malaysia's economic momentum to steadily improve heading into 2024, on the back of the fiscal consolidation by the government, as well as the potential turnaround in external demand and resilient domestic demand. In its Economic Outlook 2024 report, it expects the growth to reach 4.5%–5.5% in 2024, from an estimated 4.0% in 2023.

Meanwhile, the fiscal deficit is projected to clock in at 4.2% of the GDP in 2024, compared to the 5% estimated for 2023, reflecting the fiscal consolidation path of the government. The narrower deficit will mainly be driven by a lower subsidy bill, better management of other operating expenditures, and higher tax revenue collections from an upside in economic conditions next year. However, it added that with a need to fund critical development projects, government debt will remain relatively sticky at RM1.3 trillion in 2024 (62.7% of GDP), while debt servicing will not be insignificant at 16.1% of total projected revenue in 2024.

The risks on the horizon for Malaysia's growth will hinge largely on the global economy successfully achieving a soft landing and avoiding further escalation of geopolitical conflicts. A spike in global food and commodity prices could pressure domestic demand, as will un-intended price ripple effects of a poorly executed retargeting of RON95 subsidies in 2H2024.


It noted that the leading indicators point to signs that global trade and semiconductor demand have reached their nadir in 2023. Hence, coupled with resilient domestic demand which is supported by the benign inflation and interest rates, the growth momentum can be sustained.

CHARLIE **MUNGER:** THE MULTIDISCIPLINARY **MIND BEHIND** BERKSHIRE HATHAWAY'S SUCCESS

harlie Munger, vice chairman of Berkshire Hathaway and Warren Buffett's longtime friend and business partner, died in November 2023 at age 99. Munger, born on January 1, 1924, is an American investor, businessman, and philanthropist. Often recognised as Buffett's right-hand man, Munger has played a pivotal role in the success of one of the world's most renowned conglomerates. Beyond his association with Buffett, Munger is esteemed for his multidisciplinary approach to decision-making, his wit, and his deep insights into investing and life.

EARLY LIFE AND EDUCATION

Munger grew up in Omaha, Nebraska, and displayed an early aptitude for mathematics. He attended the University of Michigan, where he studied mathematics for three years before leaving to join the U.S. Army Air Corps during World War II. After the war, he attended Harvard Law School and later joined a law firm in Los Angeles.

INVESTMENT PARTNERSHIP AND BERKSHIRE HATHAWAY

In the late 1950s, Munger established his own law practice, but his true passion lay in investing. He started a partnership in the early 1960s, and through a series of mergers, it eventually evolved into the firm that would be later acquired by Berkshire Hathaway. Munger joined Berkshire Hathaway as Vice Chairman in 1978, marking the beginning of one of the most successful partnerships in the world of finance.

MUNGER'S INVESTMENT APPROACH

Charlie Munger's investment approach is characterized by a set of principles and mental models that emphasize a comprehensive, multidisciplinary perspective on decision-making. While Buffett is often associated with value investing, Munger complements this approach with a broader array of influences, including psychology, economics, and various academic disciplines.

HERE ARE KEY ASPECTS OF MUNGER'S INVESTMENT PHILOSOPHY:

 LATTICEWORK OF MENTAL MODELS: Munger is known for advocating a latticework of mental models, drawing insights from a diverse range of disciplines such as psychology, biology, physics, and economics. He believes that a broad understanding of different fields provides a more comprehensive view of the world, enabling better decision-making. Likewise, we too, must use all our knowledge to understand both the fundamental and behavioural aspects of investing.

- 2. INVERSION: Munger frequently employs the concept of inversion, which involves thinking backward by considering potential problems and obstacles. Instead of focusing solely on what needs to be done, Munger advises considering what should be avoided. This approach helps mitigate risks and enhances the quality of decision-making. Just as we rationalise why we should invest in a stock, we must also make an impassioned consideration of reasons why we should not invest in that stock for only then we would have considered the pros and the cons.
- **3. CIRCLE OF COMPETENCE:** Like Buffett, Munger emphasises staying within one's circle of competence. Investors should focus on businesses and industries they understand thoroughly, allowing for more informed and rational investment decisions. Munger famously stated, "The game of investing is one of making better predictions about the future than other people." Put another way, only invest in what you understand.
- **4. ECONOMIC MOATS:** Munger and Buffett both place significant importance on identifying businesses with economic moats—sustainable competitive advantages that protect a company from competitors. Businesses with strong moats are better positioned to withstand challenges and generate long-term value.
- 5. MARGIN OF SAFETY: Munger subscribes to the concept of margin of safety, which involves buying assets at a price significantly below their intrinsic value. This approach provides a buffer against unforeseen risks and market volatility. The moat and the margin of safety are the two Ms of investing the stronger these shields, the greater the protection.

FROM THE OBSERVER

- 6. LONG-TERM PERSPECTIVE: Munger encourages investors to adopt a long-term perspective. Instead of fixating on short-term market fluctuations, he believes in holding quality investments for an extended period, allowing the power of compounding to work in favour of investors.
- 7. INDEPENDENCE OF THOUGHT: Munger values independence of thought and urges investors to think for themselves. While learning from others is important, blindly following the crowd can lead to poor decision-making. Critical thinking and intellectual independence are crucial aspects of Munger's approach. Every bubble has its premise on crowd behaviour and we all know how those bubbles eventually turned out.
- 8. CONTINUOUS LEARNING: Munger is a voracious reader and emphasizes the importance of continuous learning. He believes that a curious and open mind is essential for adapting to changing circumstances and making informed decisions. Just as what we know is important, even more important is realising that there is much that we do not know. Utter humility and the disregard of ego are prerequisites for successful investing.

Charlie Munger's investment approach is distinguished by his multidisciplinary mindset, emphasis on mental models, inversion thinking, focus on the circle of competence, recognition of economic moats, adherence to a margin of safety, long-term perspective, independence of thought, and commitment to continuous learning. Munger's wisdom and principles have not only contributed significantly to Berkshire Hathaway's success but have also influenced countless investors seeking a more thoughtful and holistic approach to the world of finance.

Charlie Munger might be dead, but his wisdom and teachings still live on and will continue to spread and stay with us forever.
