Launch of cross-border QR payment linkage between Malaysia and Indonesia

ank Negara Malaysia (BNM) and Bank Indonesia (BI) launched a cross-border QR payment linkage that will enable instant, secure, and efficient cross-border payments between Malaysia and Indonesia. Through this linkage, consumers in both countries will be able to make retail payments by scanning the DuitNow or QRIS (Quick Response Code Indonesian Standard) QR codes displayed by offline and online merchants. This marks the beginning of a pilot phase that will pave the way for a full commercial launch in the third quarter of 2022. This linkage will be expanded in the future to support cross-border remittance where users in both countries can make real-time fund transfers with convenience. According to BNM deputy governor Jessica Chew Cheng Lian, the cross-border QR payment linkage between Malaysia and Indonesia marks a key milestone in the long history of collaboration between both countries. Phase 2 of the QR payment linkage between Malaysia and Thailand has also gone live this week. Such developments will bring us closer towards realising the vision of creating an Asean network of fast and efficient retail payment systems. This in turn, will further accelerate digital transformation and financial integration for the benefit of individuals and businesses. According to Bank Indonesia deputy governor Doni P Joewono, this initiative links cross-border payments through the interconnection of national QR codes of the two countries and also represents another milestone of the Indonesian Payment System Blueprint 2025. Bank Indonesia recognises the significance of cross-border payment system linkages and has continuously pursued such initiatives. This will give more options for users in the crossborder payment space and serve as a key to improve transaction efficiency, support the digitalisation of trade and investment, and maintain macroeconomic stability by promoting a more extensive use of Local Currency Settlement (LCS) Framework. Through the use of direct quotation of local currency exchange rates provided by Appointed Cross Currency Dealer banks under the LCS Framework, it will improve the efficiency of transactions thus lowering the transaction cost. The payment

connectivity will further strengthen the

close economic ties between Malaysia and Indonesia, and support post-pandemic economic recovery. As international travel resumes, tourism will be a key sector that will greatly benefit from this service. The sizeable traveller flows between the two countries recorded an average of 5.6 million arrivals yearly before the pandemic. Both countries are also key remittance corridors for their nationals working abroad who will benefit from faster, cheaper, and more transparent cross-border remittances. This initiative is also aligned with the G20 Roadmap for Enhancing Cross-border Payments developed by the Financial Stability Board and other international bodies. This project is made possible with the collaboration of various stakeholders from both countries under the joint stewardship of BNM and BI. These include Payments Network Malaysia Sdn Bhd (PayNet), the Indonesian Payment System Association (ASPI) and RAJA (Rintis, Artajasa, Jalin, and Alto) as payment system operators. The settlement banks are CIMB Bank Bhd, Bank Mandiri and Bank Negara Indonesia. Other participants include various banks and non-bank payment service providers from both countries.

Malaysia's 2021 PPI records largest annual rise in a decade after Dec's 10% gain - DOSM

According to Department of Statistics Malaysia (DOSM) chief statistician Datuk Seri Dr Mohd Uzir Mahidin, Malaysia's Producer Price Index (PPI) for local production increased by 10% year-onyear (y-o-y) in December 2021 as opposed to a decrease of 2.1% recorded in the corresponding month of the preceding year, mainly due to slower pace in primary commodities' prices but inflationary pressures continued. For 2021, the country's PPI increased 9.5% from a year earlier, the largest on-year annual rise in a decade. The increase in December 2021 was attributed to the mining index that rose 45.1% from a slump of 40% recorded in December 2020, driven by higher prices for crude oil (46.8%) and natural gas (37%). Agriculture, forestry and fishing also increased at a moderate rate of 10.9% compared to 23.5% in December 2020, largely due to the incline in the indices of fishing (12.4%), animal production (11.6%) and growing of perennial crops (11.2%). The manufacturing index increased 7.6% in December 2021, contributed by the indices for subsectors of manufacture of refined petroleum products (22.3%), manufacture of vegetable and animal oils and fats (18.1%) and manufacture of basic chemicals, fertilisers and nitrogen compounds, plastics and synthetic rubber in primary forms (15.6%). The indices for the subsectors of manufacture of plastics products, manufacture of rubber products and manufacture of basic iron and steel also moved higher, while the utilities index recorded a marginal increase of 0.9% and 0.7% for water supply and electricity and gas supply indices respectively. On a month-on-month comparison, the PPI local production recorded a decline for the first time after a consistent increase for 14 consecutive months — dropped 0.6% in December 2021, with the decline mainly contributed by mining index that registered a negative 4.2%. The index of agriculture, forestry and fishing also recorded a decline of 2.9%, driven mainly by the price of oil palm fresh fruit bunches which fell 4.9% from November 2021. Chicken price also showed a 0.8% decline. Meanwhile, the manufacturing index increased marginally 0.1%, supported by a modest increase of 0.7% for manufacture of refined petroleum products subsector besides rising prices for constructionrelated products. However, the marginal increase in manufacturing index was also offset by a drop of 0.8% for manufacture of electronic components and boards. Similarly, the indices of water supply and electricity and gas supply rose 0.5% and 0.1% respectively. For 2021, the PPI local production recorded the highest increase in a decade to 9.5%. It was the first time increase after registering a decline for three consecutive years. In 2021, world economies experienced insufficient supply problems which cannot meet rebounding demand after movement restrictions in most countries were being

lifted, which had caused disruptions to the supply chain and exerted pressure on the prices of commodity and raw materials. In addition, the unusual prolonged cold weather conditions in certain countries also led to the surge of primary commodities prices, especially natural gas. For 2022, the world is facing the threat of Omicron variant spread, which also made a significant impact on the prices of primary commodities especially crude oil.


Financial Sector Blueprint 2022-2026 to support Malaysia's next stage of development — BNM governor

The financial industry is well positioned to play a stronger role in leading transformation and changes

at the industry level, thanks to its strong foundation following two decades of development. BNM is committed to fostering conditions for greater market dynamism to respond to changing needs of the economy and society, which call for more and diverse actors in the financial system, operating within well-defined parameters that encourage healthy competition and innovation, alongside prudent and responsible conduct. BNM's approach behind the blueprint would be that financial services must help the people and businesses grow their wealth, engage in trade and commerce, and build resilience. It must help customers manage financial risks and adverse events, including climate and environment related risks to secure lasting prosperity. To this end, the blueprint seeks to align the financial sector with the national aspiration to not only become a high-value-added and high-income economy, but also lay a solid foundation for a more dynamic, inclusive and sustainable development path. The blueprint was launched by Finance Minister Tengku Datuk Seri Zafrul Tengku Abdul Aziz.

Markets

The Federal Open Market Committee (FOMC) which met this week has now more or less laid out a plan as to how it intends to tackle the runaway inflation in the US. While the Fed will begin raising rates in March, the pace of future increases will likely be data-dependent. Jerome Powell, the Fed Chair, also did not rule out the possibility of raising interest rates at every FOMC meeting thereafter. The market now is pricing in up to four more hikes after the March hike, raising the Fed Fund Rate by a full percentage point to between 1.25-1.50% from the current floor rate of 0.00-0.25%. In addition, the Fed is expected to shrink its balance sheet after the rate hike in March although the exact timing and quantum are yet to be communicated to the market.

The International Monetary Fund (IMF) reduced its 2022 global GDP growth to 4.4% from 4.9% that was forecasted in October last year, mainly on persistent inflationary pressure and covid-19 disruptions. IMF lowered its forecast for the US and China to just 4.0% and 4.8%, from the previous estimate of 5.2% and 5.6% respectively. The IMF left its 2021 GDP growth estimate for the global economy unchanged at 5.9%.

Meanwhile, Transparency International has placed Malaysia in number 62 in its 2021 Corruption Perception Index with a score of 48 pts. Malaysia dropped five spots and three points from the previous year's rank of 57 and a score of 51 pts respectively.

Economy

Out of the US, December Existing Home Sales contracted by 7.1% y-o-y to an annual rate of 6.18mil, well below the consensus estimate of 6.44mil units. For the year 2021, Existing Home Sales surged 8.5% to 6.12mil, the highest in 15 years. Interestingly, this has also led to dwindling inventories as the December data saw total housing inventory at just 910,000 units, down 14.2% from one year ago. Unsold inventory is now at just a 1.8-month supply at the present sales pace, adding further upward pressure to market prices. In other economic news, the Conference Board's US Consumer Confidence for January came in ahead of expectations at 113.8 but was still slower than the December print of 115.2 while the US trade deficit hit US\$1.08 trillion last year from US\$893.5bil in 2020 as the December trade deficit surged to a new record high of US\$101bil. US exports rose by 2% in December to US\$258.2bil while imports rose by just 1.4% to reach US\$157.3bil.

US 4Q2021 preliminary GDP saw the world's largest economy expanding by 6.9% y-o-y, well ahead of the consensus estimate of a 5.5% increase and tripled the pace of growth registered in the 3Q 2021 quarter of 2.3%. Meanwhile, US Durable Goods Order for December fell by 0.9% m-o-m, which was below market expectations of a 0.6% decline.

From Europe, the preliminary January IHS Markit Flash Eurozone Composite Index fell to an 11-month low to 52.4 from December's 53.3 print.

However, the IHS Markit Flash Manufacturing PMI saw a marginal improvement with a reading of 59.0 from 58.0 in the preceding month.

In GDP numbers, South Korea's 4Q GDP came in well within estimate as the economy expanded by 1.1% q-o-q and 4.1% y-o-y, bringing its 2021 growth to 4.0%. The Philippines meanwhile saw a big jump in its 4Q GDP as the economy expanded by 7.7% y-o-y against the market estimate of a 6.3% expansion. This brings the Philippines' full year 2021 GDP to 5.6% against the consensus estimate of a 5.1% rise and reversing the deep 9.6% contraction experienced in 2020, mainly due to the Covid-19 pandemic. The Taiwanese 4Q GDP data too was well ahead of expectations as initial estimates showed the economy expanded 4.88% y-o-y against a market estimate of just 3.8% gain. This brings the annual growth economic growth to 6.28%, almost double the 3.11% GDP growth achieved in 2020.

Down south, Singapore saw both the headline and core inflation for December surging to multi-year highs with the former at 4% and the latter at 2.1%, the highest since July 2014. In response, the Monetary Authority of Singapore (MAS) made a surprise pre-emptive move by steepening the Singapore Dollar Nominal Effective Exchange Rate (S\$NEER) slope marginally.

Locally, Malaysia's headline inflation eased to 3.2% in December from the November print of 3.3%, but core inflation inched up to 1.1% from 0.9% in November. For the year, Malaysia posted an inflation rate of 2.5%, reversing the deflation reading of 1.2% in 2020. Meanwhile, according to Bank Negara, Malaysia's international reserves as at January 14 stood at US\$116.2bil or RM484.2bil, down US\$0.7bil from US\$116.9bil as of the end of December 2021. In other news, Malaysia's December Producer Price Index-Local Production eased with a smaller y-o-y growth of 10.0% from the preceding month's 12.6% y-o-y jump. The Mining sub-index was again the fastest-growing sector, rising by 45.1% y-o-y, driven by a significant jump in crude oil and natural gas prices.

Corporate

SilTerra Malaysia, a subsidiary of Dagang NeXchange, is investing RM645mil to increase its semiconductor wafer foundry capacity by 20%. In other news, Greatec Technology announced that it has secured a RM160mil order for a production line system. Jiankun International has entered into a joint venture agreement with Menara Rezeki Sdn Bhd to redevelop Flat PKNS Jalan Tun Razak in Kampung Baru into a mixed development with a potential gross development value of RM1.12bil. Meanwhile, Nextgreen Global has entered into a Memorandum of Understanding with the Kelantan State Government to develop sustainable projects worth RM2.23bil.

In other news, Toyo Ventures Holdings (TVH) informed the Exchange that it was unable to release its annual report for the financial period ended Sept 30, 2021, as it needs more time to resolve some outstanding matters related. TVH expects to release the annual report by end of February 2022. Axiata Group too was in the news this week as it proposed to acquire a 66.03% stake in PT Link Net Tbk for RM2.55bil from its two main shareholders, Asia Link Dewa Pte. Ltd. and PT First Media Tbk. Axiata will also extend a mandatory tender offer to acquire the remaining shareholding not already owned.

Meanwhile, major board changes among the banking institutions are set to take place soon. Dato' Khairussaleh Ramli has been confirmed to assume the position of Group President and CEO of Malayan Banking w.e.f. 1 May 2022. This comes just after tendering his resignation as CEO of RHB Bank the day before. In other boardroom changes, Tan Sri Azman Hashim is expected to retire as Chairman of AMMB Holdings on 31 March 2022.

Equity

The broad sell-off on Wall Street saw almost all major equity markets falling off the cliff this week with losses ranging from as low as 0.2% of the Jakarta Composite Index to as high as 8.7% on Korea's Stock Exchange's KOSPI Index. Some major indices have dropped more than 10% from their recent tops and are now in correction territory while a couple of indices are knocking on the bear market window as they approach the 20% drop from the top. On the local bourse, selling too was broad-based as the benchmark KLCI fell 13.26 pts or 0.9% to close at 1514.49 pts.

For the week ended January 20, foreigners turned net buyers with an inflow of RM279.8mil, while both the local institutions and retail market participants emerged as net sellers with an outflow of RM259.4mil and RM20.4mil respectively.

Eye on Week Ahead

Later today, all eyes will be on the December headline and core Personal Consumption Expenditure (PCE) as consensus expects the number to hit 6.1% and 4.8% from 5.7% and 4.7% respectively in November. In addition, the Final University of Michigan Consumer Sentiment for January will also be out, with the market expecting a 68.7 print. On Monday, January 31, China will be releasing the January Manufacturing and Non-Manufacturing PMI, while the preliminary 4Q GDP data for Eurozone is also due.

On Tuesday, February 1, IHS Markit Eurozone Manufacturing PMI, The Institute of Supply Management (ISM) Manufacturing PMI, and the J.P. Morgan Global Manufacturing PMI for January are due. The next day, February 3, the Eurozone headline and core inflation data will be out. On Thursday, February 3, the IHS Markit ASEAN Manufacturing PMI and the Eurozone Composite PMI are expected to be released.

Locally, later today, the Department of Statistics will be releasing Malaysia's December external trade performance, while on Monday, Bank Negara will be releasing the December banking sector statistics. On Wednesday, February 3, the IHS Markit Malaysia Manufacturing PMI for January will be out.

Even when all is rosy, a well-thought plan can always falter

Radio-frequency identification (RFID) solution specialist SMTrack Berhad was a quiet ACE Market counter (in the technology sector) until mid-December 2021. From 8.5 sen on 15 December 2021, the counter commenced its slow ascension thereafter with tycoon Tan Sri Lee Kim Yew emerging as a substantial shareholder on 29 December following his acquisition of 28.5 million shares or a 5.05% stake from the open market. The presence of the Country Heights Holdings Bhd executive chairman had boosted the share price of SMTrack to end the year 2021 at 19 sen, representing a 123% gain in the span of a fortnight. Later, the upside momentum continued with rumours emerging that a government linked company (GLC) was eyeing a 10% stake in SMTrack (New Straits Times, 4 January 2022). According to a news report, the GLC is said to be an entity of the Ministry of Finance Inc and has made its interest known in a letter addressed to SMTrack after a meeting between representatives of both parties.

Embark on 5G journey

The positive news does not stop here. On 17 January 2022, SMTrack announced that it had entered into a head of agreement (HOA) with 5G Infra Tech Solution Sdn Bhd via a consortium consisting of six PLCs, including itself, to invest in 5G Infra Tech through redeemable convertible preference shares in the latter. 5G Infra Tech is involved in consultancy works and the export and import of a variety of goods.

This HOA is to enable the consortium to ride on the 5G and fibre optics-related projects by Digital National Bhd (DNB) as well as the Malaysian Communications and Multimedia Commission (MCMC). 5G Infra Tech plans to undertake its maiden 5G project with Ennova Sdn Bhd (Ennova), one of the contractors for 5G projects by DNB. Ennova is mainly involved in the construction and engineering of telecommunication infrastructure. It was reported that Ennova plans to install and maintain 350 telecommunication towers all over Kuala Lumpur. And with the financing from 5G InfraTech, Ennova is expected to roll out 10,000 towers all over Malaysia, said 5G InfraTech Executive Chairman Datuk Saiful Nizam Mohd Yusoff.

Points to note

Notwithstanding the seemingly rosy picture of SMTrack's outlook, minority shareholders must take note of the following:

The tendency of investors to buy on rumours and sell on news:

After touching a 52-week high of 31 sen on 10, 11 and 12 January, it seems SMTrack entered a consolidation mode. It plummeted 5.5 sen or 19% to 23.5 sen on 17 January, the day the SMTrack-led consortium inked heads of agreement with 5G Infra Tech. It closed at 22 sen on 20 January.

The diverse background of consortium members:

Except for Country Heights, the remaining five consortium members - including SMTrack – are penny stocks and includes some loss-making counters. As for SMTrack, the company remained in the red with a net loss of RM1.2 million for the quarter ended 31 October 2021. Its revenue shrank further to RM283,000 from RM425,000 in the previous corresponding period. For its financial year ended 31 July 2020, SMTrack narrowed its net loss to RM806,000 from RM3.86 million in the corresponding period in FY2019 while its revenue rose slightly to RM2 million (FY2019: RM1.51 million). Note that SMTrack had on 3 August 2021 announced the change of financial year from 31 July 2021 to 31 December 2021. Besides, the consortium members have diverse business activities - two IT companies, two property developers and two investment holding firms. It remains to be seen if they will be able to create synergy and forge a successful collaboration.

Scarce information:

As the collaboration between the consortium and 5G Infra Tech is still preliminary (with just a HOA signed), more information is required for investors to assess the prospect and potential of this new venture. An HOA is a non-binding agreement that establishes the basic framework for a partnership or transaction.

Capital requirement:

The required capital to fund this venture is unknown now. But considering that the 5G venture will be capital intensive with the

need to build network infrastructure. As such, it remains to be seen if the consortium members including SMTrack will be able to raise the required capital to fund 5G Infra Tech and reap the potential return from the 5G trend.

Track record:

The 5G business is probably an alien sector to all parties, including 5G Infra Tech which is embarking on its maiden 5G venture with Ennova. Henceforth, project planning and execution risks will be a main concern for investors.

As always, investors must not let their guard down but continue to be vigilant in their investment decisions

PN17/GN3 relaxation is over

Bursa Malaysia Securities Berhad had on 13 January dismissed AirAsia Group Berhad's appeal of seeking to extend the 18-month relief period from being classified as a Practice Note 17 (PN17) company beyond 7 January 2022. The relief period was granted by Bursa Malaysia to affected listed issuers from complying with the obligations under Paragraph 8.04 and PN17 of the Main Market. Listing Requirements (PN17 Relief Measures) for a period of 18 months (Relief Period). Pursuant to the PN17 Relief Measures, AirAsia was required to re-assess its condition at the expiry of the Relief Period on 7 January 2022.

AirAsia's share price nosedived following the news. It is probable that many thought that Bursa Malaysia would extend this concession like what it did with the extension of the 20% placement rule to raise funds. The implication of not getting such an extension is that AirAsia must now regularise its position within one year from 7 January 2022 (if the regularisation plan will not result a significant change in its business direction) or face the risk of suspension and delisting if not so regularised. In other words, the drop in share price is due to the regularisation clock starting to tick.

Minority shareholders of other PN17 or Guidance Note 3 (GN3) companies should be mindful that there is a high probability that their PN17/GN 3 investee PLCs will not be granted such extensions. The share prices of these PLCs may have already factored in this possibility.


