

MALAYSIAN ECONONY TO GROW 4% THIS YEAR - FITCH SOLUTIONS

ccording to Fitch Solutions Country Risk and Industry Research, in a statement dated Feb14, Malaysia's economic growth is expected to slow to 4.0% this year from 8.7% in 2022, due to fading of base effects and pent-up demand, tighter credit conditions and weakening global growth outlook. Based on its outlook report for 2023, the research house said that while it expects the economy to return to growth over the coming quarters, it believes the pace of economic expansion will moderate significantly with credit conditions tightening further and pent-up demand fading. Moreover, the export outlook will likely weaken further on the back of a slowing global economy and as the semiconductor industry continues to be in a downcycle.

The research house said that from a gross domestic product by expenditure perspective, the growth slowdown in the fourth quarter of 2022 (Q4'22) was broad-based, with export growth weakening the most from 23.9% year-on-year (y-o-y) in Q3'22, to 9.6% in Q4'22. Meanwhile, private consumption growth also slowed to 7.4% y-o-y, versus 15.1% in the previous quarter, while gross fixed investment expanded by 8.8%

y-o-y, as compared with 13.1% in Q3'22. In terms of growth, it expects base effects to turn unfavourable after Malaysia posted its highest growth rate since 2000. While cash handouts and subsidies on food and fuel, combined with the easing of Covid-19 restrictions drove up aggregate demand in 2022, the growth impulse is unlikely to be sustained.

Households and businesses have already drawn down on their savings considerably since April 2022 and it expects the 100bps of interest rate hikes by Bank Negara Malaysia (BNM) to gradually feed through, further weighing on consumer appetite. Accordingly, private consumption growth is expected to slow significantly to 5.0% in 2023, from 11.5% in 2022. Additionally, gross fixed investment growth is anticipated to slow markedly to 2.0% in 2023, versus 6.8% in 2022, as both domestic and external monetary conditions continue to tighten and as business confidence wanes. BNM has adopted a relatively gradual tightening approach, having hiked its policy rate by only 100bps to 2.75% since it began its rate hiking cycle in May 2022. However, an additional 50bps of hikes is expected over the coming months, as real interest rates remain negative and underlying price pressures remain elevated by historical standards, with core inflation coming in at 4.1% y-o-y in December.

As higher borrowing costs gradually feeds through, this will likely weigh on domestic and foreign businesses' appetite to borrow and invest. Malaysia's manufacturing PMI has fallen further to 46.5, marking the sixth consecutive month of decline and fifth straight month that the reading stayed below the 50 mark that separates contraction and expansion. Meanwhile, a slowing global economy will hurt exports and growth is expected to decline sharply to 3.0% in 2023, from 12.8% in 2022.

The reopening of the mainland Chinese economy should provide a tailwind for Malaysian exporters given that the latter is Malaysia's largest export destination, accounting for more than one-fifth of total outbound shipments. The tourism sector should also benefit from a revival of outbound Chinese travellers after Beijing lifted border restrictions on January 9, with China making up around 30% of



international arrivals in 2019. However, global growth is still expected to slow to 2.1% in 2023, from an estimated 3.1% in 2022, with both the US and EU likely to fall into mild recessions.

POSITIVE OUTLOOK FOR REITS SECTOR – HLIB RESEARCH

According to Hong Leong Investment Bank (HLIB) Research, the outlook remains bright for real estate investment trusts (REITs) with retail and industrial assets, supported by the return of foreign tourists and sustained demand for industrial properties. Retail malls have been experiencing an upsurge in footfall and sales as well as a significant decline in rental assistance. The retail sector still has room to grow on the back of sustained elevated footfall supported by foreign tourists from the reopening of international borders.

This was especially so for malls with meaningful exposure to foreign tourists, such as Pavilion Kuala Lumpur and Suria KLCC. The return of Chinese patronage is set to support retail performance while cushioning some downside risks arising from an economic slowdown from the west. Axis-REIT, a proxy to industrial assets, has continued to see steady growth stemming from contribution of newly acquired properties and positive rental reversion in 2022. Major enhancement works for Axis Facility 2 @ Bukit Raja and Bukit Raja Distribution Centre 2 are slated for completion and ready for tenancy in the first and third quarters of 2023, respectively, with improved rental rates. Management has also embarked on the phase 2 development of the Axis Mega Distribution Centre, which has an estimated RM130mil construction cost to be completed in the first quarter of 2024. Coupled with the RM120mil acquisition targets in 2023, HLIB Research believes this year will be "another growth year" for Axis-REIT when its expansion plans come into fruition.


The office market is grappling with pressured rental and occupancy rates, amid growing supplies of office space that is outpacing demand. HLIB Research expects the ordeals to persist, given the high impending office supply (5.1 million sq ft) expected in 2023. That is on top of the

113.9 million sq ft of cumulative office space as at the second half of 2022 in the Klang Valley, citing data from Knight Frank Research. As such, rental reversions will likely be in the negative territory, due to intense competition with the completions of multiple new Grade A office buildings. Investors are advised to exercise extra caution on office REITs as office owners are grappling with dwindling occupancy and rental rates due to the oversupply woes.

The research house is "sanguine" on Sunway-REIT due to its strategically located prime malls, hospitality assets to ride on the revival of the tourism sector, as well as diversified exposure to various asset classes. It also favours Pavilion-REIT for Pavilion KL's promising rental reversion outlook and sizable foreign tourists footfall. It likes Axis-REIT for its robust track record, occupant tenancy in its diversified portfolio and broadening expansion and acquisition pipeline.

EYE ON THE MARKETS

This week, on Friday (17Feb), the Ringgit opened at 4.4265 against the USD from 4.3400 on Monday (13Feb). Meanwhile, the Ringgit was 3.3089to the Sing Dollar on Friday (17Feb). On Monday (13Feb), the FBM KLCI opened at 1488.05. As at Friday (17Feb) 10:00am, the FBM KLCI is down 6.25 points for the week at 1481.80. Over in US, the overnight Dow Jones Industrial Average closed down 431.20 points (-1.26%) to 33,696.85 whilst the NASDAQ shed 214.76 points (-1.78%) to 11,855.83.

EXCHANGE TRADED FUND, ANOTHER INVESTIMENT CLASS FOR INVESTORS

xchange Traded Fund, commonly known as ETF, is an investment class that has gained much popularity amongst retail and institutional investors for its low expense ratio, wide range of investment choices, diversification and low investment threshold. ETFs are akin to unit trust funds except that they are traded on stock exchanges, while unit trusts are not traded on an exchange except for certain closed-end funds.

FROM THE OBSERVER

Presently, there are 19 ETFs listed on Bursa Malaysia. Their breakdown is as follows:

Commodities ETF (1), Equity ETF (6), Equity ETF (Shariah Compliant) (5), Fixed Income ETF (1) and Leveraged & Inverse ETF (6).

ETFs are gaining popularity among investors due to the following reasons:

(a) Cost-effectiveness

Similar to share trading, buy and sell ETFs incur brokerage fee, clearing fee and stamp duty. However, it enjoys much lower management fees, usually less than 1% of the fund's NAV compared to unit trusts. There is also a sale charge of 2% (on average as of 2020). Therefore, ETFs can be economical to buy and maintain in the long run.

(b) Diversified exposure

ETFs hold a basket of securities with the objective of mimicking the performance of an index. The basket may comprise shares, bonds, futures, or commodities depending on the ETF's index. The basket of asset classes offers broad diversification and averts the risk involved in owning stocks of a few companies.

(c) Flexibility and liquidity

Since ETFs are listed and quoted on stock exchanges, the buying and selling of ETFs can be done during trading hours like stocks. Therefore, investors could promptly enter and exit the market.

(d) Transparency

Investors can easily access the details of the underlying assets of ETFs. Such information is readily available at the ETF or stock exchange websites.

Nevertheless, investors must take note of a few considerations before investing in ETFs.

(a) Operating expenses

The costs incurred by fund managers in managing the ETFs are reflected in the fund's expenses ratio, which measures the percentage



of an investor's investment that will be paid to the fund each year. A higher operating expense ratio lowers an investor's total returns.

(b) Trading volume of ETFs

High trading volume of an ETF makes the ETF more liquid, and the bid-ask spread may be narrow, and liquid ETFs allow investors to exit easily. Low trading volumes make the ETF illiquid.

(c) Tracking errors

The performance of an ETF may deviate from the index's performance, resulting in a tracking error for the ETF. This means an ETF could cost more than the underlying assets, and an investor might pay a premium when buying that ETF.

(d) Designed to track, not beat

ETFs are designed to track indexes, sectors, commodities, or other assets. ETFs often will not outperform the underlying assets in the index. Investors looking to beat the market will have to consider other investment options.

(e) ETF Promotor's expertise and experience

The promotor's expertise in choosing and managing the underlying assets is also an important consideration.

To sum up, ETF simplifies investing for new and seasoned investors who need help picking individual securities or who do not have the time to monitor or pick individual securities. Investing in an ETF can diversify their exposure to different asset classes. ETFs give investors an efficient way to diversify their portfolios without having to select individual stocks or bonds. However, investors should also understand that ETFs have risks before investing in an ETF. The single biggest risk is market risk, just as investing in shares. The performance of an ETF is generally directly affected by the performance of its component stocks and bonds. Investors still need to do their homework before investing in an ETF.

Malaysia Airports Holdings Berhad (AIRPORT) is pleased to inform that as announced by the YB Minister of Transport during a media briefing on 9 February 2023, the Government has approved in principle the new material terms for the Operating Agreements between the Government and MAHB to operate, manage, maintain and develop 39 airports and STOLports until 2069.

Included within the terms and conditions of OA 2023 are the following:

- The Government and MAHB have the flexibility in the method of funding airport development costs either using Government allocations through Development Expenditure (DE) or MAHB through any suitable investment recovery model mechanism, subject to the mutual agreement of both parties with the weighted average cost of capital (WACC) to be determined only when a project will be implemented and subject to Government approval;
- The establishment of the Airport Development Fund (ADF), a development trust account under Section 9 of the Financial Procedures Act 1957 [Act 61], to receive contributions from airport users, the public and also airlines and does not involve contributions from Government funds;

- 3. 50% of the Passenger Service Charge (PSC) component that is taken into account in the calculation of the User Fee will be channelled to the ADF trust account. The percentage of PSC or percentage of other components in the User Fee to be contributed to the ADF account will be reviewed every three years; and
- 4. The Government has the right to restructure the airport industry through clustering, carving out, divestment of airports, closure of existing airports or terminals or the restructuring of the ownership of any of the facilities subject to the mutual agreement with MAHB.

The approval is a welcome development and affirms the Operating Agreements under two (2) operating frameworks as follows:

- Operating Agreement and Lease Agreement for KL International Airport (KLIA) between the Government and MAHB and Malaysia Airports (Sepang) Sdn Bhd; and
- Operating Agreement and Lease Agreement for Designated Airports between the Government and MAHB and Malaysia Airports Sdn Bhd.

Pursuant to the above approval, MAHB and the Government will proceed to finalise the relevant documents to effect the OA 2023 and the relevant terms to be incorporated prior to their execution. A subsequent announcement will be made by the Company to disclose the salient information upon signing of the new operating agreements. The OA 2023 serves as an affirmation of the airport network framework and cross-subsidisation model, allowing MAHB to continue operating underserved essential community airports as well as 17 STOLports. The agreements will benefit the country and stakeholders at large through better airport service levels and continued development of airport capacity as OA 2023 will allow and provide an opportunity for the Company to invest and reinvest in the modernisation and development of viable airports under fair and conducive commercial terms with a clear investment return mechanism. This will certainly provide the impetus in facilitating a balanced and sustainable growth for the nation's airports, which serve as an important economic development

lever for the country. Furthermore, the Government also agreed to the proposal to rebrand KLIA and klia2 to KLIA Terminal 1 and KLIA Terminal 2 to improve their marketability value and effectiveness, in addition to strengthening competition with international airports in the region. The execution of OA 2023 is expected to contribute positively to the future earnings, earnings per share and net assets per share of MAHB Group. They are not expected to have any material effect on share capital, substantial shareholders' shareholdings and gearing of the Company.

Malaysia's largest home improvement retailer MR D.I.Y Group Berhad (MRDIY) reported revenue of RM1.1 billion, a

9.3% increase year-on-year compared to the corresponding prior period, despite a challenging environment. The growth was driven primarily by a 15.2% increase in transaction volume as the Company continued to grow its nationwide footprint further. The Group's store network expanded from 900 stores in FYE2021 to 1,080 stores as of 31 December 2022 across its three brands - MR D.I.Y., MR TOY and MR DOLLAR. The Group's profit before tax (PBT) for the period rose 5.5% y-o-y to RM188.9 million led by the higher revenue. Normalised net earnings for the 4QFY2022 increased 8.7% y-o-y to RM146.3 million. Reported net earnings was RM136.1 million, or RM10.2 million lower, as a result of the one-off prosperity corporate tax levied on companies with chargeable income above RM100 million at a tax rate of 33% instead of the current normal corporate tax rate of 24%. Net normalised earnings margin for the 4QFY2022 was 13.7% compared to 13.8% in the correspondingly quarter of FY2021. The results benefitted from a rebound in gross profit margin offset by higher operating expenses, particularly from significantly higher employee cost in line with a 25% increase in the minimum wage rate, which came into effect on 1st May 2022.
